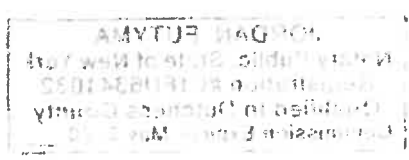
We would like to put a front porch extending 8ft. out. The setbacks used to be 10ft which the house is 10ft. off the property line now. The setbacks have changed to 20ft.
