ANSWERS TO A 1-5 ON APPLICATION

- 1) There will be no undesirable change in the character of the neighborhood or any detriment to nearby properties if these signs are approved and installed. They have been designed to compliment the building that was approved by the planning department. They are also in a neighborhood that has freestanding signs and commercial businesses.
- 2) The benefit sought by the applicant cannot be achieved by any other method than signage for the property and tenants . The signs are designed to house the amount of tenants in the commercial building approved by the planning department.
- 3) The requested area variance is not substantial if we consider it benefits nine businesses. Each panel of the directory is the same size for each tenant and is not large.
- 4) The proposed variance will not have an adverse effect or impact on the physical or environmental conditions in the neighborhood. The property is located in a business neighborhood with existing business signs. The signs have no environmental impacts on the property.
- 5) Although it may be considered self created based on the standing sign ordinance , the approvals for variances granted for the property suggest that a building approved for multiple tenants would require area variances. Being self created in itseld does not necessarily preclude the granting of the variances.

- 5) Whether the alleged difficulty was self-created, which consideration shall be relevant to the decision of the Board of Appeals, but shall not necessarily preclude the granting of the area variance.

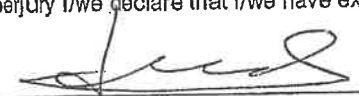

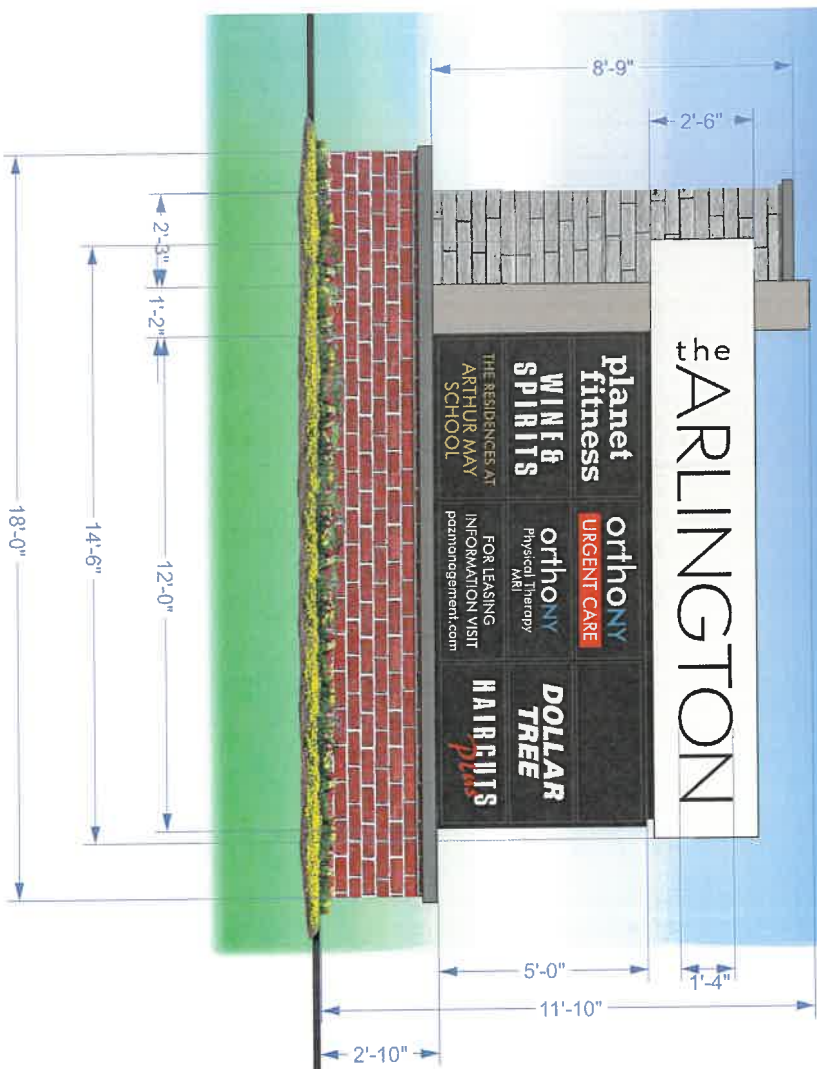

Sign Depth: 16"
 Header to be CNC routed from .125" aluminum with push-thru acrylic letters to illuminate. Tenant Cabinet to be fabricated from 2" x 2" aluminum angle with individual acrylic faces depicting tenant logo identity. Internal aluminum support system for maximum strength of form / stability. Internal illumination from LED lighting components powered by high output supplies. Decorative aluminum framework to compliment sign design from 3" x 8" rectangular aluminum tubing (welded). Sign to be set on steel support system in ground in 3,500 psi concrete footings.

Finishes: Cultured stone / brick for base and pillar with finished trincap (over steel framework, Hardie Board & PT plywood).

Colors in custom Matthews acrylic enamel paint finishes to coordinate with Buildings and black for tenant cabinet.
